WPMG Inc. 2015 AGM: President's Report

The WPMG was formed in April 2014 with 6 entities at the inaugural meeting, nearly 12 months on membership has grown to 23 entities. The group arose from the need to work together to control wild dogs, and the need to have a local organisation able to tap into outside resources for assistance on pest management issues.

The WPMG has completed two district wide baiting programs using both aerial and ground delivery of baits with varying degrees of success. This is a good starting point, in the future we hope to achieve a shorter delivery timeframe for baiting and a higher participation rate in baiting programs – this is crucial to successful group activities.

The group has applied for and received funding from 3 sources throughout the year.

1. Grant of \$4000 through Landcare to help pest management groups get established.
2. Successfully applied for funding through AWI to provide cold storage for meat (freezers) throughout the Wanaaring area. Delivery of this program in ongoing.
3. Landcare/Vertebrate Pest Management funding to supply the group with traps and cameras. This program is nearly complete.

WPMG members participated in a trapping school run at several different locations throughout the local area in August. Benefits of these schools are starting to show through with increased trapping activity taking place and increased trappings of wild dogs being reported.

The group was also able to receive assistance from Local Land Services in supplying meat for baiting and this will be ongoing for the short term.

I would like to thank Neill and Debbie Leigo for their tireless efforts in keeping the WPMG organised and moving forward, and would also like to recognise the efforts of the area representatives leading up to baitings. They are putting in a lot of effort and it seems to be working well.

Last but not least I would like to recognise the efforts of Grant Davis and his 'can do' attitude in the establishment of the WPMG, we were sorry to see him move on but look forward to working with Fred Miller and have no doubt he will be very effective.

In 2014 the Committee has worked hard to establish the Association and maximise available grant funding opportunities.

Cheque and Savings Accounts were open on 15th May 2014 with \$2,373.00 which had been held on our behalf by the Paroo Landcare Group. These funds were left over from a \$5,000.00 Grant from Thomas International Foods.

In May 2014, we applied for Landcare funding of \$4,000.00 for group activities such as Meetings and Trapping Schools. The funds were received on 29th August 2014.
