1. I REVOKE all testamentary dispositions previously made by me.
2. I APPOINT THE PERPETUAL EXECUTORS AND TRUSTEES ASSOCIATION OF AUSTRALIA LIMITED of 50 Queen Street Melbourne Victoria to be Executor and Trustee of my Will and Estate.

I DEVISE all my real estate and I BEQUEATH the residue of my personal estate to my Trustee UPON TRUST to sell and convert the same into money (with power in my Trustee to postpone the sale and conversion of my estate as my Trustee in its discretion shall decide) and out of the proceeds of such sale and conversion and out of my ready money to pay my

debts funeral and testamentary expenses and the said legacies and all duties payable in consequence of my death and subject thereto I direct my Trustee to hold the residue of my estate in perpetuity for charitable purposes as a charitable trust to be known as "The Carleton Family Charitable Trust" the net income thereof to be distributed each year to such charitable organisations within the State of Victoria as my Trustee in its discretion from time to time shall decide.

8. I DIRECT that the receipt of the Treasurer or other appropriate officer of any institution named in my Will as a beneficiary shall be a sufficient discharge to my Trustee for the payment by my Trustee to such institution of any amounts due to be paid under my Will and that my Trustee shall in no way be responsible for the application of any such moneys.

9. I DECLARE that my Trustee shall have the power to invest any money required to be invested in any investments of whatever kind my Trustee shall select and whether or not any such investment is authorised for the investment of trust moneys including (but without limiting the foregoing) real estate shares in public companies unit trusts and trustee company common funds.
