After more than fifteen years of formal Incorporation, Friends of Nepal Inc continues to remain committed to our main focus of fundraising to support disadvantaged communities in Nepal at a 'grass roots' level.

In view of the time constraints of committee members during this financial year our fundraising events were minimal. In an effort to work smarter we established a GoFundMe page for the RIDS Nepal - Syada Village Project which raised an encouraging \$1,953. This meant that together with a lunch at the Agni Indian Restaurant and a Bunnings Sausage Sizzle we were raised \$3,700, sufficient for us to be in a position to forward \$3,000 to our primary beneficiary RIDS Nepal.

We continue to be supported by our very generous sponsors and committee members to whom we say a very big 'Thank You'. Income raised from sponsorship and membership subscriptions enable us to cover our administration and running costs. Other general donations allow us to be in a position to offer grants to other smaller projects on application.

As we look to 2020, we will continue our commitment to support RIDS Nepal but hope also to be in a position to support other small community-based projects.



For the year ended 30 June 2019 FON produced a net surplus of \$2,464.


Significant Changes in State of Affairs

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Friends of Nepal is a not-for-profit entity incorporated and domiciled in Australia.

The directors have the power to amend and reissue the financial statements

(a) Basis of Preparation

1. The financial statements, which includes Balance sheet, Profit and Loss and cashflow statement has been prepared in accordance with generally accepted accounting principles.
2. The financial statements have been prepared on a cash basis of accounting
3. In the Committee's opinion, the entity is not a reporting entity because there are no users dependent on the financial statements and as such the report is prepared for internal use.

(b) Cash and cash equivalents

Cash and cash equivalents in the Statement of Financial Position comprise of cash on hand and cash at bank.

(c) Revenue recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the entity and the revenue can be reliably measured. Generally, revenue is recognised when the funds are deposited in the bank or cash is received.

(d) Taxes

(i) Income tax

The entity is an income tax exempt charitable entity and has been registered as such with the Australian Taxation office

(ii) Goods and Services Tax (GST)

The entity has obtained GST charity concession from the Australian Taxation Office

(e) Fundraising activities

As a charitable institution, the entity is has requirements under the Department of Commerce, Western Australia, Charities code of practice. This code provided the manner in which fundraising appeals are conducted, controlled and reported.

The entity is also registered with the Australian Charities and Not-for-profits Commission (ACNC)
