#### Opinion

# NOTES TO THE SPECIAL PURPOSE FINANCIAL STATEMENTS FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2018

#### 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements are special purpose financial statements prepared in order to meet the requirements of the members of MLC Foundation (Inc) ("the Foundation") and the Associations Incorporation Act 2015. The special purpose financial statements have also been prepared in accordance with the requirements of Australian Charities and Not-for-profits Commission Act 2012 (ACNC Act). The Foundation has prepared the financial statements on the basis it is not publicly accountable and is a non-reporting entity because there are no users dependent on general purpose financial statements. The Board has determined that the Foundation is not a reporting entity. The Foundation is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The Foundation was incorporated on 20 June 1988 in Western Australia. Its primary purpose is to provide for the advancement of education of girls in Western Australia by promoting and providing financial support for education at Methodist Ladies' College.

The financial report has been prepared on an accrual basis and is based on historical costs, unless otherwise stated in the notes.

The financial statements have been prepared in accordance with the significant accounting policies disclosed below. Such accounting policies are consistent with prior periods unless stated otherwise.

#### a) Cash

For the purpose of the Statement of Cash Flows, cash includes cash on hand, deposits at call which are readily convertible to cash on hand and which are used in the cash management function on a day-to-day basis, net of outstanding bank overdrafts.

## b) Financial Assets

Equity investments designated as at fair value through other comprehensive income (FVOCI)

On initial recognition, as long as the equity instrument is not held for trading, the Foundation may make an irrevocable election (on an instrument-by instrument basis) to designate investments in equity instruments as at FVOCI.

A financial asset is held for trading if:

It has been acquired principally for the purpose of selling it in the near term; or On initial recognition it is part of a portfolio of identified financial instruments that the Foundation manages together and has evidence of a recent actual pattern of short-term profit-taking.

Investments in equity instruments as at FVOCI are initially measured at fair value plus transaction costs. Subsequently, they are measured at fair value with gains and losses arising from changes in fair value recognised in other comprehensive income and accumulated in the asset revaluation reserve. The cumulative gain or loss is not reclassified to profit or loss on disposal of the equity investments, instead, it is transferred to accumulated funds. Dividends on these investments in equity instruments are recognised in profit or loss in accordance with AASB 9, unless the dividends clearly represent a recovery of part of the cost of the investment. The Foundation has designated all investments in equity instruments that are not held for trading as at FVOCI on initial application of AASB 9. Equity instruments as at FVOCI are not subject to an impairment assessment.

The Foundation derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. Derecognition of an investment in equity instrument which the Foundation has elected on initial

recognition to measure as at FVOCI, the cumulative gain or loss previously accumulated in the asset revaluation reserve is not reclassified to profit or loss but is transferred to accumulated funds.

#### c) Revenue

Revenue is measured at the fair value of the consideration received or receivable.

Interest revenue is recognised using the effective interest method.

Donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

#### d) Income Tax

The Foundation is exempt from income tax under Subdivision 50-B of the Income Tax Assessment Act (1997).

#### e) Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred are not recoverable from the Australian Tax Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST Recoverable from, or payable to, the ATO is included with other receivables or payable in the statement of financial position.

#### f) Other Payables

Other payables are recognised when the Foundation becomes obliged to make future payments resulting from the purchase of goods and services.

#### g) Critical Accounting Estimates and Judgments

The Board members evaluate estimates and judgement incorporated into the financial report based on historical knowledge and best available current information.

Estimates assume reasonable expectation of future events and are based on current trends and economic data obtained both externally and within the Foundation.

## h) Adoption of new and revised standards

In the year ended 31 December 2018, the Board has reviewed all the new and revised Standards and Interpretations issued by the AASB that are relevant to the Foundation and effective for the current reporting periods beginning on or after 1 January 2018.

As a result of this review, the Foundation has adopted AASB 9 Financial Instruments with an initial application of 1 January 2018. As a result, the Foundation has changed its accounting policy for Financial Assets (refer Note b)). The Foundation has applied AASB 9 retrospectively.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

h) Adoption of new and revised standards (continued)

The directors of the Foundation determined the existing financial assets as at 1 January 2018 based on the facts and circumstances that were present and determined that the initial application of AASB 9 had the following effect:

The Foundation's investments in equity instruments not held for trading that were previously classified as available-for-sale financial assets and were measured at fair value have been designated as at fair value through other comprehensive income (FVOCI). The movement in fair value on equity instruments continues to be accumulated in the asset revaluation reserve. When an equity investment as at FVOCI has a gain or loss previously recognised in other comprehensive income, it is not reclassified to profit or loss (on disposal). There is no change required for accounting for dividends reinvestments. Equity instruments as at FVOCI are not subject to an impairment assessment.

In prior year, as there were sales of equity instruments a restatement of the comparative amounts was required.

The statement of profit or loss and other comprehensive income for the year ended 31 December 2017 was restated, profit decreased by \$1,765 and other comprehensive income increased by \$1,765.

The statement of changes in equity for the year ended 31 December 2017 was restated, a transfer within equity from reserves to accumulated funds of \$1,765 was required for equity investments disposed of during the year.

No change to the 31 December 2017 statement of financial position was required.

Standards and Interpretations in issue not yet adopted

The Board has also reviewed all the new and revised Standards and Interpretations in issue not yet adopted for the year ended 31 December 2018. The Board has determined that there is no material impact of the new and revised Standards and Interpretations on the Foundation and therefore, no material change is necessary to Foundation accounting policies.
