## **Centipede's Child Services**

## **Standard Childcare Services**

The 'Standard" childcare services are those that are funded by Commonwealth and State Government subsidies with the funding 'gap' made up from Parent/Carer fees and grants\*.

Centipede provides the full range of standard out-of-school-hours (OOSH) services of Before School, After School and School Vacation child caring for the children of South Glebe, in particular, those attending Glebe Public School. These are children whose ages range from 5 to 12 years. \* The CoS Sydney's grant is to be allocated only to the

implementation of these Standard Childcare Services

Before and After School Childcare provides supervised outdoor games and sports as well as dance on occasion and provides for the development of healthy bodies, team work and cooperation and coordination in working with others. Passive activities include table games and puzzles, books and reading, supervised and managed computer use and toys appropriate to children's ages. These activities are managed to provide both intellectual stimulation as well as a quiet time according to individual needs.

#### **School Vacation Childcare**.

In addition to the above, this Service has excursions to places of interest and the ever popular swimming days. Some vacation care activities are sponsored enabling Centipede to be bolder in its programming. Thanks to a grant from the Lord Mayors Salary fund last year we have had camping excursions during some vacation periods and hope to continue them in the coming year.

## **Extended Childcare Services**

Centipede is more than a regular OOSH service. Additional and special activities and actions are required to fulfil the special needs of Centipede's children. These are outlined below.

#### **Good Start Breakfast Club**



To get a good start to the school day thus enhancing learning ability about 25 children are provided with a simple breakfast. This is done in conjunction with Red Cross who

provide cereals, milk, bread, spreads and volunteer cooks. In the evening a nutritious meal is provided to about 40 children.

#### **Mileposts**

Centipede's name for recognition of achievements and for celebrations of events in a child's life and events of cultural significance in the community. These are events such as birthdays, religious festivals and the like through individual and group celebration and by the giving of gifts and presentation of special achievement awards. Sorry Day and NAIDOC Week are important elements of this service.

## Skills 4 Life

Addresses special needs children's issues in After School and School Vacations by providing sufficient trained staff to enable closer attention, monitoring and management of those children who have behaviour and emotional problems arising from their environment. Maximising the children's time away from their

normal environment is an essential part of this Service.

## **Government Agency Services**

These are children's and family services aimed to provide a particular outcome.

# **Active After-school Communities**

A service sponsored by the

Australian Sports Commission fitting in with After School Childcare. It allows for the engagement of specialist sports coaches and physical educators and brings Centipede children into team events after school with children from other places.



This service has been renewed for a further 12 months.

## **Funding**

To pay for Centipede's work and workers the Association depends on funds from Governments, Parent/Carers, Benefactors, Donors and its own fund raising. Governments and Benefactors alike condition their grants by contracts that specify detailed performance criteria. Generally, Benefactors do not provide funds for recurrent expenses but only for specific Services or Projects. Governments' funding is directed towards standard OOSH Services (including recurrent expenses) or for particular additional Services (e.g. Active After School Communities). Assets acquisition and capital costs as well as its additional workforce above the norm are carried by the Association through whatever it can obtain from

Benefactors or its own fund raising.

Friends of Centipede. In 2012, The Management Committee set up a fundraising arm called the Friends of Centipede. During 2012 it was able to sign up some 35 members as well as raise \$10,000 at a fundraising event held in conjunction with The Glebe Society who have been pivotal in providing support.

Fee Collections remains a problem for the group although Centipede has raised the level of Parent/Carer fee obligation and collection rates have improved. Reminders of outstanding accounts are sent out on a monthly basis but even so payment of these accounts is sluggish. We need to encourage the prompt payment of fees to ensure that the centre remains viable and that we comply with a requirement specified under funding from the City of Sydney. The Quikkids programme which handles our billing and collections is providing a lot of information that is enabling us to identify slow payers and take the appropriate action.

Australian Child Care Fee Subsidy (CCB) is an Australian Government

scheme,administered by the Family Affairs Office (FAO), which subsidises child caring costs for Parent/Carers who register and are accepted as eligible for the subsidy. The amount of CCB is derived from a formula including




Parent/Carer's income, number of children and each child's attendance at its nominated child caring organisation. In Centipede's case that amount is paid directly to Centipede.

Centipede is also obliged to charge and collect a Parent/Carer fee for each child. Centipede's fee is offset by the amount of CCB that Centipede receives.

Our current daily fee structure is as follows:

Before School Care \$14.00 After School Care \$18.00 Vacation Care \$38.00



#### **Child Attendance**

The Association keeps regular, reliable and accurate records of children's attendance at Standard Childcare Services. Average attendance at each Service is consistent over the period showing a very slight decline for Before School and a slight increase for After School and Vacation Care. The daily averages over the period are shown in the chart below.

Knowledge of levels of attendance enables the Association to determine the number of staff to employ so as to maintain adequate staff to children ratios in accordance with the Association's Policy.



# **Expenses**


A detailed account of our costs is provided in the financial statements attached to this report. As you can see from the chart below, employment is our major cost factor. This cost is directly related to the number of children in our care and the requirement to maintain legislated ratios of staff to child numbers. We had a deficit for this financial year of \$43,299. There were a number of one off expenses during the year which contributed to the deficit.

\$20,000 accreditation costs \$10,000 Camping trips funded from The Lord Mayor's Salary fund recognised in last year's accounts

\$5,500 refund of premiums to GIO \$3,000 replacement IT equipment
