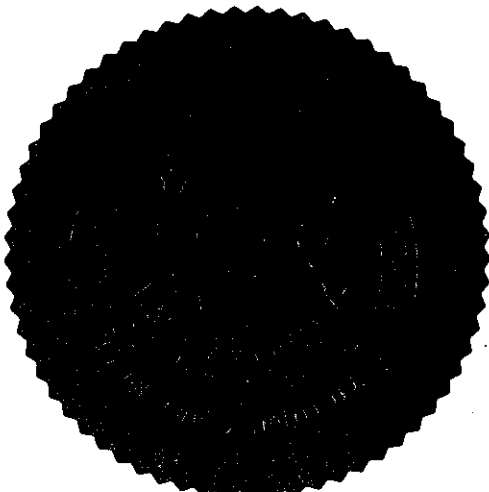

THIS IS THE LAST WILL of me ROBERT MITCHELL CHEFFERS

1. I REVOKE all prior wills and testamentary dispositions.

2. I APPOINT **EQUITY TRUSTEES LIMITED** of 575 Bourke Street, Melbourne as my executor and trustee ("my trustee"). Any reference in my will to 'my trustee' shall unless the context otherwise requires, include the trustee or trustees of my will whether original, additional or substituted.

3. I GIVE all of my real and personal estate ("my estate") to my trustee upon the following trusts:
 - (a) to sell, call in and convert my estate into money with power to postpone such sale, calling in and conversion for so long as my trustee may think fit;
 - (b) to pay from my estate all my just debts, funeral and testamentary expenses, probate and death duties, capital gains tax and other like duties and taxes payable on or in respect of my estate and the costs involved in the execution of the trusts of my will;
 - (c) to hold the balance of my estate then remaining ("my residuary estate") for the establishment of a perpetual trust (to be known as the Margo, Bonnie and Emma Perpetual Memorial trust) to pay or apply all or part of the net annual income to **MACFARLANE BURNET INSTITUTE FOR MEDICAL RESEARCH AND PUBLIC HEALTH LTD** of 85 Commercial Road, Melbourne or its successor for the purposes of research into infectious diseases, improvement in public health in Australia and overseas and for education in clinical health and upon such terms and conditions as may be determined from time to time by

my trustee. I DIRECT that the receipt of the finance officer, secretary or other proper officer of the organisation shall be a full and sufficient discharge to my trustee.

4. I DIRECT that my trustee shall have the following powers:
- (a) pending the sale, calling in and conversion of my estate to retain as an authorised investment such assets as my trustee may think proper;
 - (b) to invest all or any part of my residuary estate pursuant to the provisions of Part 1 of the Trustee Act 1958;
 - (c) to accumulate at the discretion of my trustee all or any part of the income received in a financial year. Any income accumulated shall form part of the capital of the trust fund. My trustee shall pay any tax due in respect of the accumulated income out of income or capital of the trust fund.
5. I declare that **EQUITY TRUSTEES LIMITED** shall be entitled to charge and be paid the following fixed commissions:-
- (a) in its capacity as executor of my will, the published scale as applicable at the date of my death;
 - (b) in its capacity as trustee of my estate, an annual fee of point nine six per centum (0.96%) per cent plus GST on the total value of the assets being administered for the time being pursuant to each and every continuing trust created in my will or which by law shall come into operation as a consequence of my death, to be charged with such frequency out of income and/or capital as determined by it in its absolute discretion, such annual fee however to be no less than its prevailing minimum scale of charges (currently \$2,145).

6. In addition, **EQUITY TRUSTEES LIMITED** shall be entitled to charge hourly fees for the following services: preparing every estate and trust return as required by the Australian Taxation Office; acting as Director in my estate/trust; managing a business as part of a trust; engagement in litigation (other than litigation arising from its default or neglect); and shall be entitled to receive any fees permitted by statute with respect to investments as well as payment for all disbursements incurred in the due administration of my estate
7. IT IS MY WISH that my dog Emma if she survives me be humanely put to sleep if possible at the Glen Huntley Veterinary Clinic and her body cremated and that her and my ashes be placed scattered together outside my bedroom window at my place of residence.
