Notes to and forming part of the Financial Statements

1. Activities

City Community Care Incorporated administers and supports the operation of the Early Bird Cafe which operates from the premises of St Stephen's Uniting Church at 197 Macquarie Street, Sydney.

The Early Bird Cafe provides breakfast Monday to Friday to the disadvantaged members of the Sydney CBD community, and other services (medical, clothing, hygiene for example consistent with its Constitution have been provided as required.

It operated throughout the year, whilst still being impacted by the Covid19 Pandemic. It continues to provide a take-away service instead of the once-traditional table service. Customer numbers have continued to grow. Measures are underway to extend operations to Saturdays. Increased costs have been matched by increased levels of donations from corporate and individual supporters

2. Accounting Methodology

- (a) The Committee has determined to utilise the cash accounting methodology for the preparation of the financial statements.
- (b) The financial statements do not account for inventory of food and kitchen supplies purchased.

3. Purpose of City Community Care Incorporated

The activities of City Community Care Incorporated, represented by these financial statements, are to be a charitable association in accordance with the Definitions and requirements under the Income Tax Assessment Act and other relevant legislation, and to carry out and work towards the following (but not limited to) charitable purposes:

- (a) the advancement of community development and the relief of those in need by reason of disadvantage in the Sydney City Council area; and
- (b) to develop day-to-day running and funding necessary:
 - (i) to provide breakfast for those who are disadvantaged:
 - (ii) for any other project which may, from time to time, be considered necessary and appropriate for those who are disadvantaged; and
 - (iii) relieve hardship and to work in partnership with other bodies and agencies to assist with the relief of hardship and to provide food, clothing, shelter and associated medical referral and care to those persons who are disadvantaged,

as provided for in its Constitution.

4. Financial Reporting

These financial statements have been prepared for presentation to the members of City Community Care Incorporated at its 2024 Annual General Meeting. City Community Care Incorporated is:

- (a) a charity registered (on 23/10/2014) with the Australian Charities and Not-for-profits Commission (ACNC), operating only in NSW, and
- (b) is registered as an incorporated association (on 11 August 2014) in NSW under the Associations Incorporation Act 2009.

Pursuant to these registrations, City Community Care Incorporated is classified as a:

- (a) Tier 2 association (total revenue less than \$250,000) and current assets less than \$500,000) by Fair Trading NSW, and
- (b) a Small Charity (annual revenue less than \$250,000 using the Australian Accounting Standards (AAS) set by the Australian Accounting Standards Board (AASB). and is not required to lodge financial statements or have them reviewed or audited. These financial statements will form the basis of City Community Care Incorporated's financial reporting by 31 December 2024 via the Annual Information Statement 2024 to the ACNC.
